1. WHO WE ARE:

2. WHAT PERSONAL DATA WE COLLECT AND WHY WE COLLECT IT:

- **Basic Data.** From the first moment you interact with our site, we are collecting data. Sometimes you provide us with data and other times data about you is collected automatically.
